MINUTES OF MEETING

A regular meeting of the Board of Supervisors of the Amelia Concourse Community Development District was held Tuesday, July 21, 2026, at 11:00 a.m. at the Amelia Concourse Amenity Center, 85200 Amaryllis Court, Fernandina Beach, Florida 32034.

The following is a summary of the discussions and actions taken at the July 21, 2026 meeting.

FIRST ORDER OF BUSINESS

Roll Call

Mr. Laughlin called the meeting to order at 11:00 a.m. and called the roll.

SECOND ORDER OF BUSINESS

Public Comment

There being none, the next item followed.

THIRD ORDER OF BUSINESS

Staff Reports (1)

A. District Engineer – Update on Dream Finder’s Request Relating to the Swales Behind Orchid Blossom Trail

Mr. Yuro informed the Board that he received no response from Dream Finders on the request for them to fund the clearing of underbrush. Dream Finders was also given Amelia

Walk's terms in order for them to grant an easement, to which Dream Finders directed work to be stopped on the project. He expects the water management district to get involved at some point.

B. Landscape Maintenance

Mr. Laughlin informed the Board that a resident has reported there is a tree at the border of the preserve that is growing over the resident's property. The water management district has given approval to remove the tree given that it is invasive. The Greenery has provided a proposal to remove the tree totaling \$1,336. Mr. Smolarsky opined that the tree is healthy and not in danger of falling.

The Board's consensus was to leave the tree in place as it is healthy and is not endangering any property at this time.

Mr. Busby stated that the pond banks off Snapdragon have not been mowed since June.

Mr. Smolarsky responded that he would look into why they were missed and get crews out to mow them.

FOURTH ORDER OF BUSINESS

Approval of Minutes of the May 19, 2026 Meeting

On MOTION by Mr. Toohey seconded by Ms. Chamerda with all in favor, the May 19, 2026 meeting minutes were approved as presented.

FIFTH ORDER OF BUSINESS

Update on Amenity Center Renovations

There were no new updates. It was noted more discussion would be needed at the September meeting to begin the project after the busy season.

SIXTH ORDER OF BUSINESS

Acceptance of the Fiscal Year 2025 Audit Report

Mr. Laughlin presented the fiscal year 2025 audit report, noting there were no deficiencies or negative findings to report.

On MOTION by Mr. Toohey seconded by Ms. Snow with all in favor the fiscal year 2025 audit report was accepted.

SEVENTH ORDER OF BUSINESS

**Public Hearings for the Purpose of Adopting
the Budget and Imposing Special
Assessments for Fiscal Year 2027**

Mr. Laughlin presented the budget, noting there is no increase in assessments being proposed.

On MOTION by Mr. Toohey seconded by Ms. Chamerda with all in favor, the public hearing was opened.

Ann Bachand thanked the Board for not raising assessments.

On MOTION by Ms. Chamerda seconded by Mr. Busby with all in favor, the public hearing was closed.

A. Consideration of Resolution 2026-06, Relating to Annual Appropriations and Adopting the Budget for Fiscal Year 2027

Mr. Toohey stated that while it was balanced out by using surplus funds to avoid an increase in assessments, the expenditures did increase overall, therefore an increase will be likely next year so the board will have to discuss that in depth at the next budget workshop.

On MOTION by Mr. Toohey seconded by Ms. Snow with all in favor, resolution 2026-06, relating to annual appropriations and adopting the budget for fiscal year 2027 was approved

B. Consideration of Resolution 2026-07, Imposing Special Assessments and Certifying an Assessment Roll

On MOTION by Ms. Snow seconded by Mr. Busby with all in favor, the public hearing was opened.

Mr. Laughlin stated that the assessment roll will be sent to the property tax collector in order for the assessments to be collected via the property tax bills.

There were no comments from members of the public.

On MOTION by Mr. Busby seconded by Mr. Toohey with all in favor, the public hearing was closed.

On MOTION by Ms. Chamerda seconded by Ms. Snow with all in favor, Resolution 2026-07, imposing special assessments and certifying an assessment roll was approved.

EIGHTH ORDER OF BUSINESS

Discussion of Fishing in District Ponds

Mr. Laughlin stated that he, Ms. Mullins and Mr. Greenberg met with some residents that live on the ponds and discussed fishing and what could be done. The main question would be whether to allow, or not allow fishing in the ponds. Additionally, Mr. Laughlin is trying to get a memorandum of understanding in place with the Sheriff's Office to direct them to trespass anyone using the pond banks.

Mr. Greenberg stated that there have been issues with children riding e-bikes around the perimeter of the ponds. He asked that another e-blast be sent to the residents that reiterates that riding anything around the perimeter of the ponds is prohibited and may result in the Sheriff's Office being called. Other than that, he believes most of the issues with the ponds have been reduced. Next, he informed the Board that he has asked Ms. Mullins to get a proposal to install a fence around the outfall structure and to install a 'No Trespassing' sign to keep kids from climbing on the grates.

Ms. Chamerda asked to hear from the residents in attendance.

David Jensen stated that a big attraction to moving to the community was the ability to fish on the ponds. He teaches his children how to properly fish and does not mind people fishing on the pond behind his property.

Andy Sweatt stated that there has been a significant improvement in the issues since the recent e-blasts were sent to the community, however there are some outliers.

Ms. Mullins went over the proposals for fencing in the outfall structure ranging from \$1,475 to \$1,900.

On MOTION by Mr. Toohey seconded by Mr. Busby with all in favor, the proposal from Gaines Fence totaling \$1,475 was approved.

Mr. Greenberg asked the Board if they were okay with an experienced homeowner providing a free class to the community on the responsible way to fish in the ponds.

Mr. Busby stated that he was opposed to encouraging fishing.

On MOTION by Ms. Chamerda seconded by Ms. Snow with four in favor and Mr. Busby opposed, holding a fishing class at the amenity center with the rental fee to be waived was approved.

Next, the board discussed the proposals for the fence repair along Amelia Concourse totaling \$225 and \$510.

On MOTION by Ms. Chamerda seconded by Mr. Toohey with all in favor, the proposal to repair the fence panels from Gaines Fence totaling \$225 was approved.

NINTH ORDER OF BUSINESS

Staff Reports (2)

A. District Counsel

Ms. Gentry informed the Board that the e-bike bill and sovereign immunity limit increase bill were vetoed by the Governor. Her firm will provide more information on the bills that passed and guidance on accepting electronic payments. Next, Ms. Gentry reminded the board members to complete four hours of ethics training. Lastly, Ms. Gentry reported that Dream Finders has asked about the money sitting in the acquisition account for the Phase 3 bonds and if they can be reimbursed. They have been advised that they need to submit valid invoices and to confirm the expenses were in accordance with the engineer's report. They were also advised of the maintenance and structural concerns the Board has in Phase 3. She will report back when there is any movement.

B. District Manager – Consideration of Designating a Regular Meeting Schedule for Fiscal Year 2027

Mr. Laughlin presented the proposed meeting schedule for fiscal year 2027 with meetings to take place on the third Tuesday of every other month at 11:00 a.m. at the amenity center.

On MOTION by Ms. Chamerda seconded by Ms. Snow with all in favor, the fiscal year 2027 meeting schedule was approved as presented.

C. Field Operations Manager

1. Report

A copy of the operations report was included in the agenda package for the Board's review. Ms. Mullins informed the Board that the permit for roof was approved. The Board asked to move the project to right after school starts since the amenity center will have to be closed during the construction.

The proposals were discussed under agenda item VIII.

Emma Jensen also stated that the playground could use a shade structure and mulch.

FIFTH ORDER OF BUSINESS

Scope of Work

Amelia Concourse – Exterior Painting & Column Repairs

1. Preparation

- Pressure wash and clean all exterior surfaces to be painted.
- Remove loose or peeling paint.
- Scrape and prepare surfaces as needed.
- Any new material/repair needs to be textured to match existing.
- Protect windows, doors, stone, pavers, landscaping, fencing, and other areas not being painted.

2. Column & Stucco Repairs

- Inspect all exterior columns and stucco surfaces for cracks, chips, and damaged or deteriorated areas.
- Remove loose material and repair damaged areas with appropriate stucco/concrete repair material.
- Repair cracks and damaged areas on columns, column bases, capitals, arches, and other architectural features.
- Blend repairs so they are smooth and ready for painting.
- Notify manager of any significant structural damage discovered before proceeding.

3. Exterior Painting

Paint all existing painted stucco and architectural surfaces, including:

- Exterior stucco walls.
- Columns and column bases/capitals.
- Arches and architectural details.
- Fascia and exterior trim.
- Covered soffits.
- Door and window surrounds.
- Ceiling under the outside overhang is stained and does not need to be painted. If paint is sprayed, these areas should be masked off.

Stone veneer, pavers, metal fencing, and gates are not to be painted.

4. Paint Requirements

- Use a high-quality exterior paint suitable for stucco and Florida weather.
- Prime repaired areas as needed.
- Apply a minimum of two finish coats for complete and uniform coverage.
- Paint colors to be approved by manager before work begins.

5. Cleanup & Final Touch-Up

- Contractor shall keep the work area clean throughout the project.
- Remove all debris and materials upon completion.
- Repair any paint overspray or damage to surrounding areas caused by the contractor.
- Complete a final walkthrough with manager and correct any missed areas or touch-ups.

- Total cost for the complete scope of work.
- Cost for column/stucco repairs.
- Cost for painting.
- Paint manufacturer/product and number of coats.
- Estimated start and completion dates.
- Warranty information.
- Any items recommended but not included in the base price.

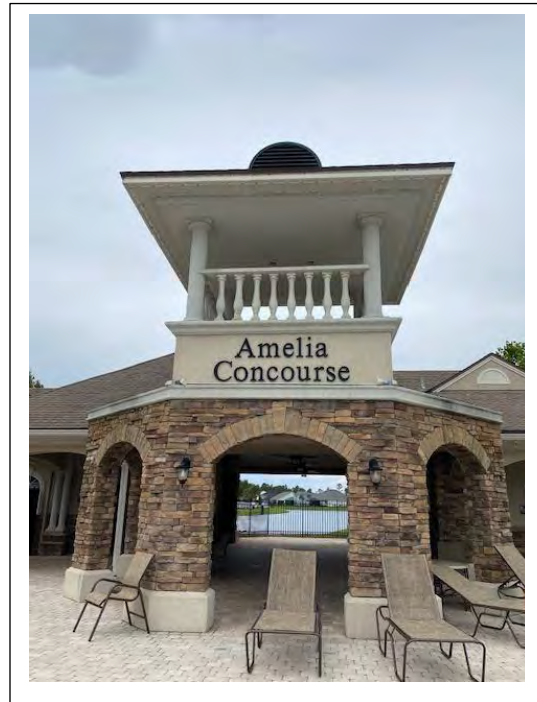

 - GMS has been sending out monthly newsletter email blasts and summaries of CDD meetings to increase communication and transparency with residents.
 - Message board at entrance is being updated per HOA request for meeting dates.

Operations Updates

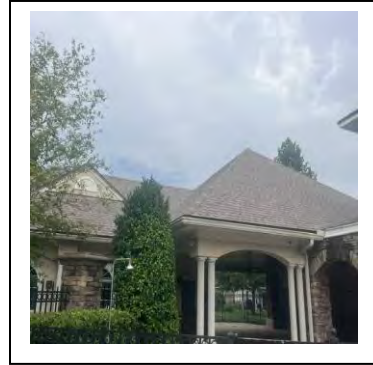
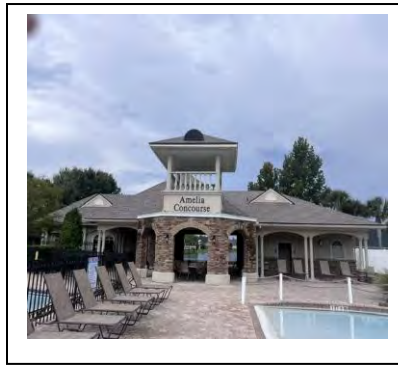
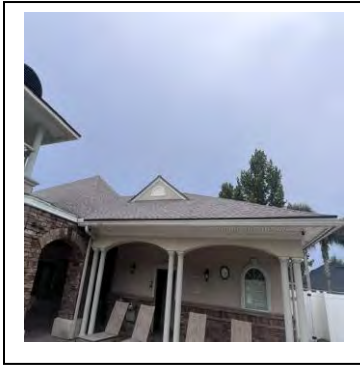
- GMS staff is monitoring the security system and cameras, making necessary corrections, and notifying the security company when any technical issues arise.
- All amenity center rental requests are being scheduled and coordinated by GMS.
- New resident and replacement cards are being coordinated and distributed by GMS.
- Checks payable to the CDD for replacement cards and reservations are being deposited and documented by GMS.
- GMS staff is rearranging the meeting room as necessary after HOA meetings and resident rentals.
- Garbage is being taken to the curb weekly by GMS staff.
- Pool chemicals are being checked and ordered by GMS.
- Restrooms and social room are being cleaned. Trash is being emptied once a week, or more often by management if needed. Bathrooms are being restocked as necessary.

Pool Usage

- July - Approximately 938 patrons accessed the main gate. The daily average was 30 patrons.
- August – Approximately 848 patrons accessed the main gate. The daily average was 27 patrons.

These numbers do not include children and guests, only those with an access fob.

Completed Projects – Roof Replacement



- The roof replacement project was completed in mid-August. The county passed the new roof inspection.

In Progress Projects



- The Board approved a proposal to pressure wash the parking lot sidewalk, curbing, paver stone walkway, amenity building pillars, pool deck, playground, and splash park. This work will commence once the water restrictions are lifted.
- The wading pool has been closed for the summer due to a broken motor. Because of low usage, a decision was made not to repair it. The pool has been drained and will remain closed while plans for its demolition and the installation of new shade structures are finalized.

Community Update – Ponds



- Superior Waterways completed the necessary steps to stock ponds 4 through 7 with carp. A new carp barrier was installed on Pond 7, and three barriers were replaced on Pond 4. An amendment to the current carp permit with Florida Wildlife Commission (FWC) was filed. The FWC inspected the barriers and issued a permit for the carp stocking. The ponds will be stocked in October.
- Monthly pond treatment reports are being sent with a summary of the work performed. Please see July and August 2026 reports below.
